Abstract:

Transforming communities is more than a goal, it is achievable if planned and implemented with a strategic vision. This interactive workshop on Operationalizing Collective Impact will help preventionists understand the steps and resources needed to engage in a Collective Impact effort in their home communities.

The workshop will review lessons learned from ICRC-S, SPRC, and the WY research. Components of the manual designed for implementation of CI as part of a comparative research study and how these efforts lead to suicide safer communities will be shared.

Learning objectives include:

- 1. Understanding what Collective Impact (CI) "is"
- 2. Understanding what CI "is not"
- 3. Learning about an example of CI as it impacted Suicide Prevention (SP)
- 4. Knowing the basic premise and design of the CI comparative research project underway in WY
- 5. Understanding some components necessary for operationalizing CI for SP

The presentation will cover:

- 1. What is Collective Impact?
- 2. How do we Operationalize it?
- 3. A look at one example of CI for SP
- 4. A review some components necessary for operationalizing CI for Suicide Prevention

This workshop will help jumpstart your prevention efforts by aiding in diagnosing the capacity for CI in your community, and providing a clear implementation pathway. Lessons learned from 50 years of suicide prevention have been incorporated into the model which is further strengthened by a comprehensive logic model for suicide prevention in communities, which emphasizes a multi-directional approach and strong outcome measures. While the national suicide rate has risen by nearly 18% over the past decade the state of WY has maintained a relatively flat rate. While the goal is to decrease the rate of suicide a lack of increase in the face of rising rates should be taken into consideration and reviewed as successes in the face of globally rising rates.
