Substance use disorders (SUDs) are key risk factors for both fatal and non-fatal suicidal behaviors. Consequently, SUD treatment program providers are in frequent contact with high-risk individuals. However, no prior work has explored the efficacy of suicide-specific interventions conducted in SUD treatment. Researchers at the University of Michigan and Eastern Colorado Health Care System are conducting an ongoing multi-site randomized controlled trial of a Cognitive-Behavioral Intervention versus a Supportive Psycho-Educational Control for suicidal Veterans seen in Veterans Health Administration (VHA) intensive outpatient SUD treatment. The current presentation would be categorized under the “Research” track. The proposed workshop has four primary components: an overview of the research project (Ariel Friese) a presentation on preliminary participant demographics (Karson Stevenson), a description of the therapeutic conditions (Karson Stevenson), and a presentation on the development and utilization of a suicide risk protocol with individuals receiving ongoing care within a large health system (Ariel Friese).

The learning objectives will be achieved through 1) a presentation of preliminary data describing participant demographics, including drug of choice, suicidal ideation and previous attempt history, and mental health status, 2) a discussion of our approach to suicide risk assessment, including the development of our risk protocol, techniques for training staff, and challenges related to suicide risk assessment in the context of a research project.
